**BY-LAW NUMBER 2018-011-01  
MODIFYING THE BY-LAW ESTABLISHING  
THE PLANNING ADVISORY COMMITTEE NUMBER 2018-011**

**WHEREAS** the By-Law establishing the Planning Advisory Committee number 2018-011 of the Township of Wentworth is in force;

**WHEREAS** a Notice of Motion was given on May 1<sup>st</sup>, 2023;

**WHEREAS** the Draft By-Law was presented on May 1<sup>st</sup>, 2023;

**THEREFORE** it is proposed by Councillor Pierre Demers and  
**RESOLVED**

**THAT** Council adopt "By-Law number 2018-011-01, modifying the By-Law establishing the Planning Advisory Committee number 2018-011":

**ARTICLE 1**

Article 13 "Tenure of Members" of the By-Law establishing the Planning Advisory Committee 2018-001 is modified by :

1. The modification in the first paragraph of the words the first Tuesday of September by the words "at the regular September meeting."

**ARTICLE 2**

Article 14 "Committee Meeting" of the By-Law establishing the Planning Advisory Committee number 2018-011 is modified by:

1. The deletion of the 2<sup>nd</sup> paragraph;
2. The insertion, after the 1<sup>st</sup> paragraph, of the following paragraph:

"The applicant of an application that is submitted to the Committee in accordance with Chapter IV of the Act respecting Land Use Planning and Development may present the application to the Committee. The Chairperson shall allow the applicant a specified period of time and shall invite the applicant to answer questions from the members. The applicant must leave the meeting before the members deliberate in caucus. The applicant must notify the Committee secretary in writing of his or her presence at least 72 hours prior to the Committee meeting."

**ARTICLE 3**

Article 21 of this By-Law is deleted

**ARTICLE 4**

Article 22 of this By-Law is replaced by the following:

**"22. Committee Members' Salary**

The citizen members of the Committee do not receive any remuneration; they may be reimbursed for their expenses regularly incurred in the performance of their duties, previously authorized by Council. In addition, supporting documentation must be attached to expense accounts."

**ARTICLE 5**

In case of difference between French and English versions, the French version prevails.

**ARTICLE 6**

The present By-Law comes into force in accordance with the Law.
