## Lake Louisa Outlet Project

Following the 2024 survey of Lake Louisa residents, the Municipality commissioned an engineering firm to analyze the lake's outlet. This study aims to assess the feasibility of two scenarios:

- The repair of the outlet in its current form;
- Or a repair that would raise the level of the lake.

The analysis will compare regulatory implications, costs, timeframes, and missing data needed to move forward with this project.

### Outdoor Lighting: What You Need to Know

The zoning by-law regulates outdoor lighting to preserve the beauty of the starry sky. In the front yard, a maximum of two ground or freestanding light fixtures is permitted per lot, with no limit in the side or rear yard. These fixtures must not exceed 2.1 meters in height, the light source must be covered, and the lighting must not be directed upward or extend beyond the property boundaries.



### Do you make the distinction?

Some clarification is needed regarding the difference between packaging and protection. Only polystyrene food packaging (e.g., meat packaging) is acceptable in the blue bin.

For protective polystyrene (e.g. packaging for household appliances), it must be placed in the trash
